## Bachelor seminar and bachelor thesis in summer term 2021

#### **Topics** Ι.

For the summer term 2021 the topics listed below will be assigned as Bachelor theses. They are required to be written as a National Report (country reports from a German perspective), study of comparative law or academic paper in English.

- 1. Homeoffice in the Time of Corona An analysis from the perspective of German tax law
- 2. Homeoffice in the Time of Corona An analysis from the perspective of international taxation
- 3. Tax Incentives for Energy Efficiency Improvements in the Building Sector A first appraisal of para. 35c of the German Income Tax Act
- 4. Reforming Energy Taxation in Europe
- 5. Should there be a European excise duty on carbon intensive goods?
- 6. Loss carry backwards or accelerated depreciation what is the better instrument to support businesses in times of Corona?
- 7. VAT and the Hospitality Sector
- 8. Transitional Provisions in the German VAT Code

#### II. **Workload and ECTS**

- Participation in the seminar sessions and writing a bachelor thesis in English language (25) pages), Interim presentation and discussion of the results in English (approx. 30 minutes)
- 3 ECTS for the seminar on the bachelor thesis (ungraded part of the work)
- 12 ECTS fort the bachelor thesis (graded part of the work)
- Student must register for the seminar as well as the written work via meinCampus

Please send us the application form "Application for the seminar and the bachelor's thesis" (see StudOn) and your current transcript of records. Applications received after this date cannot be considered. Topics will be assigned to two candidates by lot on 12.04.2021 and must be written independently by each participant. Should the pre-registrations exceed the planned capacity, seminar participants will be selected according to suitability.

It is <u>not possible to swap</u> topics. A binding registration must be submitted by **22.04.202** at the latest. If there is no response by then, we will assume the topic was rejected. In this case there will be no registration for the Bachelor seminar.
