

Bachelor seminar and bachelor thesis in winter term 2022/23

I. Topics

For the winter term 2022/23 the topics listed below will be assigned as Bachelor theses. They are required to be written as a National Report (country reports from a German perspective), study of comparative law or academic paper in English.

- 1. Tax Incentives for Energy Efficiency Improvements in the Building Sector – A first appraisal of para. 35c of the German Income Tax Act**
- 2. Reforming Energy Taxation in Europe**
- 3. Should there be a European excise duty on carbon intensive goods?**
- 4. Tax Technology in International Direct Taxation**
- 5. Income Taxation and Inflation**
- 6. The German Energy Allowance – What kind of income is it?**
- 7. The German Energy Allowance – Does it serve its purpose?**

II. Workload and ECTS

- Participation in the seminar sessions and writing a bachelor thesis in **English language** (25 pages), Interim presentation and discussion of the results in English (approx. 30 minutes)
- 3 ECTS for the seminar on the bachelor thesis (ungraded part of the work)
- 12 ECTS for the bachelor thesis (graded part of the work)
- Student must register for the seminar as well as the written work via Campo

III. Mentoring

Professor Dr. Roland Ismer and research assistant Stefanie Göllich.

Appointments for meetings will be arranged individually with the tutors to further elaborate and delimit the content of the topic.

IV. Time frame

Time frame for the students of the bachelors degree Business Studies/ Wirtschaftswissenschaften and comparable courses at WISO is from 10.11.2022 until 12.01.2023 (9 weeks).

The creation phase is based on the study examination regulations applicable to your degree program. You will find further information there.

V. Registration

Please register for the Bachelor's Seminar **by 28.10.2022, 12:00 am (cut-off deadline!)** at the latest via E-Mail (stefanie.guellich@fau.de) for the bachelor seminar. Please send us the application form "Application for the seminar and the bachelor's thesis" (see StudOn) and your current transcript of records. Applications received after this date cannot be considered. Topics will be assigned to two candidates on **02.11.2022** and must be written independently by each participant. Should the pre-registrations exceed the planned capacity, seminar participants will be selected according to suitability.

It is not possible to swap topics. A binding registration must be submitted by **09.11.2022** at the latest. If there is no response by then, we will assume the topic was rejected. In this case there will be no registration for the Bachelor seminar.

For the formal structure of the thesis, reference is made to the Chair's guidelines for the preparation of a scientific paper. For the winter term 2022/23 the deadline is 12.01.2023.
